

RESULTS OF THE 2015 ANNUAL TOWN MEETING

MARCH 14, 2015

The Town of Cranberry Isles 2015 Annual Town Meeting was held on Saturday, March 14, 2015, at the Cranberry Island Congregational Church. The Town Clerk, Denise McCormick, opened the meeting at 9:05 a.m.

The Warrant Articles were acted upon as follows:

1. To elect by ballot a Moderator to preside at said meeting.

Barbara Meyers nominated Barbara Fernald.

Six votes cast, six votes Barbara Fernald.

2. To elect by ballot a Town Clerk for the ensuing year and to vote compensation.

Kelly Sanborn nominated Denise McCormick.

5 votes cast, 5 votes Denise McCormick.

Sheila Krasnow motions to set compensation at \$6,825, 2nd by Bruce Fernald.

Unanimous vote to set compensation at \$6,825.

3. To see if the voters of the Town of Cranberry Isles will approve the use of the Maine Municipal Association's recommended Maine Moderator's Manual "Rules of Procedures" for the conduct of this Town Meeting.

Bruce Fernald motions to approve, 2nd by Sheila Krasnow.

Unanimous vote to approve.

4. To see if the voters of the Town of Cranberry Isles will approve opening the floor of this Town Meeting to all non-registered persons, for the purpose of discussion only, on each of the following articles of this 2015 Warrant.

5. To elect by ballot a Selectman for the term of three years.

Bruce Fernald nominated Phil Whitney. Phil declined nomination.

Karin Whitney nominated Bill Dowling. Bill declined nomination.

Nanette Hadlock nominated Ed Gray. Ed declined nomination.

Jason Pickering nominated Phil Whitney. Phil declined nomination again.

Barbara Meyers nominated Ted Spurling. Ted declined nomination.

Joanne Thormann motions to take Article #6 out of order, she suggests if maybe we increased the amount of compensation for the board of selectmen, maybe then people would be more inclined to run and serve the office. Charles Dunbar 2nd the motion.

Unanimous vote to take Article 6 out of order, and act on that before going back to Article #5.

6. To Vote compensation for all the Selectmen for the ensuing year.

Joanne Thormann motions to set compensation at the recommended amount of \$2000 for Chairman \$1700 for others, 2nd by Charles Dunbar.

There was a lengthy discussion about whether that is an appropriate amount of yearly compensation for the amount of work the Selectmen do. Different sums were discussed and most felt the recommended amount was not sufficient. Joanne Thormann withdraws her motion to set compensation at the recommended amount.
