## **RESULTS OF THE MARCH 12, 2016 ANNUAL TOWN MEETING**

## FOR THE TOWN OF CRANBERRY ISLES

The Annual Town Meeting of the Town of Cranberry Isles was held on March 12, 2016 at the Neighborhood House on Islesford. The Town Clerk, Denise McCormick, called the Meeting to order at 8:33 a.m. There were 68 Registered Voters present.

The following articles were voted on as follows:

1. To elect by ballot a Moderator to preside at said meeting.

Richard Beal nominated Barbara Fernald.

There were no other nominations.

3 Votes Cast, 3 Votes for Barbara Fernald.

The Town Clerk administered the Oath of Office to the Moderator.

2. To elect by ballot a Town Clerk for the ensuing year and to vote compensation.

Kelly Sanborn nominated Denise McCormick.

There were no other nominations.

4 Votes Cast, 4 Votes Denise McCormick.

The Moderator administered the Oath of Office to the Town Clerk.

William Dowling motions to set compensation for the Town Clerk at \$7,000 annually, seconded by Tammy Palmer.

Unanimous Vote to Approve compensation of \$7,000.

3. To see if the voters of the Town of Cranberry Isles will approve the use of the Maine Municipal Associations recommended Maine Moderator's Manual "Rules of Procedures" for the conduct of this Town Meeting.

Jeri Spurling motions to approve, seconded by Thomas Powell.

4. To see if the voters of the Town of Cranberry Isles will approve opening the floor of this Town Meeting to all non-registered persons for the purpose of discussion only on each of the following articles of this 2016 Warrant.

Jeri Spurling motions to approve, seconded by Sheila Krasnow.

Unanimous Vote to Approve.

5. To elect by ballot a Selectmen for the term of three years.

Kelly Sanborn nominated Richard Beal.

Karin Whitney nominated William Dowling.

59 Votes Cast, 42 Votes Richard Beal, 17 Votes William Dowling.

6. To vote compensation for all the Selectmen for the ensuing year.

Ingrid Gaither motions to set the compensation at \$3,000 for the Chairman and \$2,000 for others, seconded by Phil Whitney.

Jason Pickering motions to amend the amounts to \$4,000 for the Chairman and \$3,000 for others, seconded by Eric Sandberg.

17 Votes Yes, 11 Votes No to amend the compensation amounts to \$4,000 and \$3,000.

Cory Duggan motions to amend the amounts to \$8,000 for the Chairman and \$7,500 for others, seconded by Kaitlyn Duggan.

30 Votes Yes, 16 Votes No to amend the compensation amounts to \$8,000 and \$7,500.

After a lengthy discussion, Katelyn Damon motions to call the question, seconded by Jason Pickering.

Majority votes to call the question, with 2 Votes to oppose.

57 Votes Cast to set compensation at \$8,000 for the Chairman, and \$7,500 for others.

39 Votes Yes, 18 Votes No.

7. To elect by ballot a Town Treasurer for the ensuing year and to vote compensation.

Sheila Krasnow nominated Denise McCormick.

There were no other nominations.

4 Votes Cast, 4 Votes Denise McCormick.

Sheila Krasnow motions to set compensation at \$10,000, seconded by Serena Spurling.

Unanimous Vote to Approve.

8. To elect by ballot a Collector of Taxes and Collector of Excise Taxes for the ensuing year and to vote compensation.

Beverly Sanborn nominated Denise McCormick.

There were no other nominations.

4 Votes Cast, 4 Votes Denise McCormick

Josh Gray motions to set the compensation at \$28,000, seconded by Richard Beal.

9. To elect by ballot a member of the Superintending School Committee for a term of three years.

Serena Spurling nominated Amy Palmer.

There were no other nominations.

8 Votes Cast, 8 Votes Amy Palmer.

10. To elect by ballot a member of the Municipal Advisory Commission, which consists of seven elected volunteer property owners or registered voters of the Town of Cranberry Isles, who shall serve a period of three years each.

Ingrid Gaither nominated Branden Stubbs.

4 Votes Cast, 4 Votes Branden Stubbs.

11. To elect by ballot a member of the Municipal Advisory Commission, which consists of seven elected volunteer property owners or registered voters of the Town of Cranberry Isles, who shall serve a period of three years each.

Ingrid Gaither nominated Jasmine Samuel.

5 Votes Cast, 5 Votes Jasmine Samuel.

12. To elect by ballot a member of the Municipal Advisory Commission, which consists of seven elected volunteer property owners or registered voter of the Town of Cranberry Isles, who shall serve a period of three years each.

Cory Duggan nominated Nicholas Barton.

5 Votes Cast, 5 Votes Nicholas Barton.

13. To elect by ballot a member of the Municipal Advisory Commission, which consists of seven elected volunteer property owners or registered voters of the Town of Cranberry Isles, who shall serve a period of three years. (Term expiring in 2017, to fill a vacant seat whose term would have expired in 2017.)

5 Votes Cast, 5 Votes Chris White.

14. To vote hourly rate of pay for Town Officials and Employees.

Richard Beal motions to set amounts to \$12 to \$25 per hour, seconded by Sheila Krasnow.

Unanimous Vote to Approve.

15. To see if the voters of the Town of Cranberry Isles will vote to collect interest at the rate of seven percent (7%) APR on all 2016 taxes not paid by December 01, 2016. Municipalities may, by vote, determine the rate of interest that shall apply to taxes that become delinquent during taxable year 2016 until those taxes are paid in full. The maximum rate of interest that can be charged per Title 36, MRSA §505.4 is seven percent (7%) APR.

Cory Duggan motions to approve, seconded by Bruce Fernald.

16. To see if the voters of the Town of Cranberry Isles will vote to allow a two percent (2%) discount on all taxes which are paid in full within thirty (30) days of the date shown on the original bill as submitted by the Tax Collector.

17. To see if the voters of the Town of Cranberry Isles will vote to authorize the Treasurer to expend funds in January 2017, February 2017, and March 2017 equal in aggregate to three twelfths (3/12ths) of the Operations Budget approved for the Year 2016. This authorization will permit the Treasurer to prepare Financial Warrants for approval by the Board of Selectmen, prepare checks, and legally pay bills pending approval of the entire Operations Budget by the Voters in March 2017.

Richard Beal motions that the School Committee be authorized to expend \$51,919 for Facilities Maintenance, seconded by Sheila Krasnow.

Unanimous Vote to Approve.

18J. To see what sum the School Committee is authorized to expend for Debt Service and Other Commitments for the fiscal year beginning July 1, 2016 and ending June 30, 2017.

Sheila Krasnow motions that the School Committee be authorized to expend \$71,031 for Debt Service and Other Commitments, seconded by Bruce Fernald.

18K. To see what sum the School Committee is authorized to expend for All Other Expenditures for the fiscal year beginning July 1, 2016 and ending June 30, 2017.

Bruce Fernald motions that the School Committee be authorized to expend \$-0- for All Other Expenditures, seconded by Ted Spurling.

Maine Revised Statutes, Title 20-A, section 15688 for the period of July 1, 2016 to June 30, 2017. Hand Count Required.

William Dowling motions that the voters of the Town of Cranberry Isles appropriate \$145,080 for the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and raise \$131,603 as the Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688 for the period July 1, 2016 to June 30, 2017, seconded by Bruce Fernald.

Hand Count Votes were 30 Votes Yes, 1 Vote No.

18M. To see what sum the voters of the Town of Cranberry Isles will raise and appropriate for the annual payments on debt service previously approved by the legislative body for non-state-funded school construction projects, non-state-funded portions of school construction projects and minor capital projects in addition to the funds appropriated as the local share of the Town of Cranberry Isles' contribution to the total cost of funding public education from kindergarten to grade 12 for the period July 1, 2016 to June 30, 2017. Hand Count Required.

William Dowling motions that the voters of the Town of Cranberry Isles raise and appropriate \$71,031 for the annual payments on debt service previously approved by the legislative body for non-state-funded school construction projects, non-state funded portions of school construction projects and minor capital projects in addition to the funds appropriated as the local share of the Town of Cranberry Isles' contribution to the total cost of funding public education from kindergarten to grade 12 for the period July 1, 2016 to June 30, 2017, seconded by Kelly Sanborn.

Hand Count Votes were 32 Votes Yes, -0- Votes No.

18N. To see what sum the voters of the Town of Cranberry Isles will raise and appropriate in additional local funds for school purposes (Recommend: \$305,354) for the period July 1, 2016 to June 30, 2017, which exceeds the State's Essential Programs and Services allocation model by (Recommend: \$302,085) as required to fund the budget recommended by the School Committee. Written ballot Vote Required.

Katelyn Damon motions that the voters of the Town of Cranberry Isles raise and appropriate \$305,354 in additional funds for school purposes for the period July 1, 2016 to June 30, 2017, which exceeds the State's Essential Programs and Services allocation model by \$302,085 as required to fund the budget recommended by the School Committee, seconded by Barbara Meyers.

22. To see if the voters of the Town of Cranberry Isles will vote to authorize the Municipal Officers to appropriate twenty thousand dollars (\$20,000) to be placed in capital reserve funds for the purchase of a new plow truck, sander and related equipment for Little Cranberry Island (Islesford).

Majority Vote to Approve, 4 Votes to Oppose.

At 1:15 p.m., Barbara Fernald, moderator, calls the meeting to order.

- 23. To see if the voters of the Town of Cranberry Isles will vote to authorize the Municipal Officers to enter into a multi-year contract (Municipal Joinder Agreement) with the Municipal Review Committee, Inc. (MRC), an agreement that would send municipal solid waste to a new processing facility, if financially advantageous. Adoption of this warrant article will authorize the following:
  - (i) to authorize the Town to continue as a charter member community of the Municipal Review Committee, Inc. (MRC), organized as a Maine nonprofit corporation and acting as a regional association pursuant to Title 13B and Title 38 of the Maine Revised Statutes, as amended (and specifically Section 1304-B (5-A) of Title 38) for the purpose of managing and facilitating solid waste disposal;
  - (ii) to adopt, ratify and confirm the Restated Articles of Incorporation and the Restated Bylaws of the MRC in substantially the form on file with the Town Clerk and posted as part of this Warrant;
  - (iii) to authorize the Town to execute and deliver a Municipal Joinder Agreement with the MRC in substantially the form on file with the Town Clerk and posted as part of this Warrant (the "Municipal Joinder Agreement") pursuant to which the Town will become a Joining Member of the MRC (as defined therein) and deliver its municipal solid waste for disposal to a waste management facility being developed by Fiberight, LLC and/or its affiliates (collectively, "Fiberight") in Hampden, Maine, or other waste disposal facility;
  - (iv) to authorize the MRC to take certain actions on behalf of the Town as set forth in the Municipal Joinder Agreement; and
  - (v) to authorize a majority of the Selectmen or their duly authorized designee or designees to execute and deliver the Municipal Joinder Agreement on behalf of the Town and to execute and deliver on behalf of the Town in conjunction therewith such other documents and to take such further actions as they may deem necessary or appropriate in order to effect the transactions contemplated by the Municipal Joinder Agreement.

Richard Beal motions to approve, seconded by Sheila Krasnow.

24. To see if the voters of the Town of Cranberry Isles will vote to authorize the Municipal Officers to appropriate and expend up to ten thousand dollars (\$10,000) for capital expenditure for a well to be located on Town property for the municipal garage at Islesford, and to further authorize the Muncipal Officers to do any and all things necessary to award and enter into necessary design and construction contracts on behalf of the Town, expend the funds, and all other things reasonably necessary to accomplish the purpose of this article.
