Dear Mr. Beal,

Thank you for your recent letter requesting information regarding land in the town where Maine Coast Heritage Trust holds an interest. All such land is on Great Cranberry Island and falls into one of two categories; Preserves or Conservation Easements. Preserves are properties that MCHT owns in fee and manage directly. Conservation Easements are privately held lands, where MCHT holds a layer of conservation protection specific to each property but has no direct management rights.

MCHT owns two preserves on Great Cranberry Island that we manage for public use: 1.7 acres at Preble Cove and 19.3 acres at Cranberry Shores at the south end of the island. Each has a trail providing access to the shore and receive regular public use. Additionally, we hold six conservation easements, two of which are composed of multiple lots. Conservation easements provide development or other management restrictions specific to each parcel, but do not usually provide public access. The easements at Spurling Cove, Preble Cove & Western Way grant public access to specific places on each property with management rights retained by the owners.

The attached map shows the preserves in blue and the easements in green. The list includes our project name, ownership per tax records, the map and lot, and approximate size. I should note that the Dolly Hill easement is made up of six lots, and I believe I have captured the appropriate map and lot information.

I hope this provides some clarity on our work as it relates to your town. I would be happy to talk on the phone or meet in person to discuss this information or to answer any other questions you may have.
