

# TOWN OF CRANBERRY ISLES SPECIAL TOWN MEETING – AUGUST 2006

# THE WARRANT

State of Maine County of Hancock, ss.

To: A constable of the Town of Cranberry Isles, in said County

## **GREETINGS:**

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the Town of Cranberry Isles, qualified to vote in town affairs, to meet at the Islesford Neighborhood House, in said Town on the 15<sup>th</sup> day of August AD 2006, at 9:00 AM to act on the following articles, to wit:

### ARTICLE:

- 1. To elect by ballot a moderator to preside at said meeting per Title 30-A MRSA §2525 (1)A.
- 2. To see if the voters of the Town of Cranberry Isles will approve use of the Maine Municipal Association's recommended Maine Moderator's Manual "Rules of Procedures" for the conduct of this meeting.
- 3. To see if the voters of the Town of Cranberry Isles will approve opening the floor of this Town Meeting to all non-registered citizens for the purpose of discussion only on the following warrant articles.
- 4. Shall an updated "Floodplain Management Ordinance" for the Town of Cranberry Isles be enacted? (See 2005 Town Report)

Note: This ordinance will repeal and replace the existing outdated TCI Floodplain Management Ordinance enacted January 10, 1991. Recommended by National Flood Insurance Plan.

- 5. To see if the voters of the Town of Cranberry Isles will vote to change the nomination and election procedure, for Town officials in the position of Selectman, Town Clerk, Town Treasurer, Collector of Taxes and Collector of Excise Taxes, to a procedure of nomination papers and secret written ballot as specified in Maine statute Title 30— A M.R.S.A. § 2528." (Citizen's Petition)
- 5A. Should Article 5 be passed, to see if the voters of the Town Of Cranberry Isles will vote to hold a Municipal Election Day, on March 9 (Friday) 2007.
- 6. To see if the voters of the Town of Cranberry Isles will vote to repeal an ordinance entitled "Vehicle Waste Disposal Fee Ordinance," (attached hereto) which was initially enacted at the March 2004 Cranberry Isles Town Meeting. (Citizen's Petition)
- 7. To elect by ballot a member of the Shellfish Conservation Committee, to complete the unexpired term of Richard Beal, which runs to March, 2008.
- 8. To elect by ballot a member of the Municipal Facilities Commission, to complete the unexpired term of Michael Phillips, which runs to March, 2007.
- 9. To elect by ballot a member of the Superintending School Committee to complete the unexpired term of Leslie Horvath which runs to March, 2007 per Title 30-A M.R.S.A. § 2525 (1C).


