

GREETINGS:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the Town of Cranberry Isles, qualified to vote in Town affairs, to meet at the Great Cranberry Fire House, on Great Cranberry Island, in said Town on the 14th day of December 2005, at 9:00 AM to act on the following articles, to wit:

ARTICLE:

- 1. To elect by ballot a moderator to preside at said meeting per Title 30-A MRSA §2525 (1)A.
- 2. To see if the voters of the Town of Cranberry Isles will approve use of the Maine Municipal Association's recommended Maine Moderator's Manual "Rules of Procedures" for the conduct of this meeting.
- 3. To see if the voters of the Town of Cranberry Isles will approve opening the floor of this Town Meeting to all non-registered citizens for the purpose of discussion only on the following warrant article.
- 4. To see if the voters of the Town of Cranberry Isles will authorize the municipal officers to appropriate from Undesignated Fund Balance up to \$30,000 for the purpose of finishing construction of the Town of Cranberry Isles Transfer Station.

Undesignated Fund Balance: \$69,381.59
