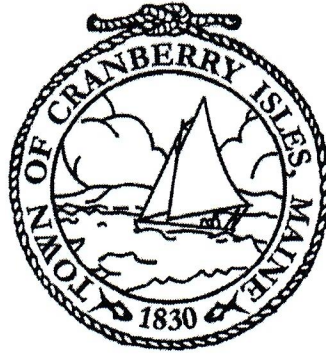

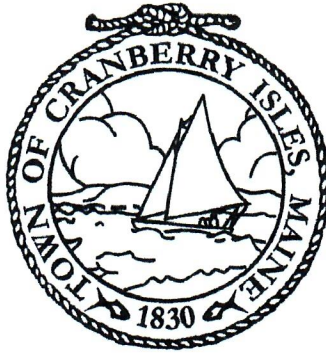

Call to Order: 8:30 A.M. by Selectman Aaron Gray.

I. Warrant for School Reorganization Referendum

Voted: An emergency meeting of the Board of Selectmen was posted and called in order to comply with regulations for the school reorganization referendum time limits.

That it be and is hereby Ordered that the Article set for the below be placed on the ballot of a Special Town Meeting of the Town of Cranberry Isles to be held on November 04, 2008. That a public hearing will be held on or before October 25, 2008; that the Warrant for the Special Town Meeting and the Notice of Public Hearing be approved in form presented to this meeting; and that the attested copy of this Order be placed on file with the Town Clerk of the Town of Cranberry Isles:

Article 2: Do you favor approving the school administrative reorganization plan prepared by the Mount Desert Reorganization Planning Committee to reorganize the Bar Harbor School Department, Mount Desert School Department, Southwest Harbor School Department, Tremont School Department, Cranberry Isles School Department, Frenchboro School Department, Trenton School Department, Maine School Administrative District No. 76 (Swans Island) and Mount Desert Regional School District into an Alternative Organizational Structure with an effective date of July 1, 2009?

The Selectmen sign the order. A Public Hearing will be posted upon decision of the School Committee at the September 17, 2008 School Board Meeting.

The Board of Selectmen also initial a change order for Dunbar and Braun for construction location and design of the Islesford Municipal Garage.
