II. Review/Approval of Meeting Minutes: January 30, 2020

Richard Howland moves to approve the January 30, 2020 Harbor Committee meeting minutes as written. Sam Donald seconds the motion. **Motion approved 3-0.**

III. Requests for Use of the Manset Dock for loading and unloading passengers (Summer 2021)

Ted Spurling presents Selectmen's request to review Mike Brzezowski's request to use Manset dock twice daily for loading and unloading a maximum of six sailboat passengers from August to October. Manset Harbormaster Dennis Dever advises that he has no objections. General discussion. Richard Howland moves to recommend allowing Manset dock usage by Mike Brzezowski for 2021. Ted Spurling seconds the motion. **Motion approved 3-0.**

IV. Other Business

Ted Spurling presents email from alternate Harbor Committee member Chris Costello for discussion. General discussion of mooring fields at GCI and LCI docks, visibility issues with winter mooring buoys, and consideration of reopening the channel from Northeast Harbor to GCI. Consensus of the Harbor Committee is to recommend that larger buoys be installed on moorings that are more difficult to see in the winter. Richard Howland will ask captains for recommendations of buoys that should be larger. Ted Spurling moves to recommend Board of Selectmen pursue plan to redesign and move mooring fields at GCI and LCI. Sam Donald seconds the motion. **Motion approved 3-0.**

Islesford Harbormaster Bruce Fernald reports that Sam Brooks has requested three moorings for his dock. General discussion. No objections raised.
