REPORT OF SUPERINTENDENT.

To the Superintending School Committee and Citizens of Cranberry Isles:

There has been a complete change in the teaching force since the last report.

Islesford Primary—Marjorie Bunker, \$21 per week.
Islesford Grammar—James Brown, \$23 per week.
G. C. I. Primary—Theolyn Rumill, \$22 per week.
G. C. I. Grammar—H. Leon Andrews, \$23 per week.

Following is the number of pupils in each grade and also the number in each school:

Grade 1—0 boys, 5 girls.
2—4 boys, 4 girls.
3—3 boys, 2 girls.
4—1 boy, 2 girls.
5—3 boys, 3 girls.
6—0 boys, 8 girls.
7—3 boys, 3 girls.
8—7 boys, 6 girls.
Total—21 boys, 33 girls.

This is a total of 54 pupils, or a gain of 14 over last year. Islesford, 20 pupils; Great Cranberry Island, 34.

There are 9 students receiving higher education in different schools of the State, as follows: Higgins Classical Institute, 1; Northeast Harbor, 1; Bar Harbor, 3; Ellsworth, 3; Bucksport Seminary, 1.

If you notice table above, you will see that there are 13 pupils to graduate from the eighth grade next June,

and if these intend to enter a higher school next year, the tuition bill will be much heavier than this year.

In closing, I wish to thank the superintending school committee and citizens for their hearty support during the year.

REPORT OF
SUPERINTENDING SCHOOL COMMITTEE.

To the Citizens of Cranberry Isles:

We have examined the report of the superintendent of schools, and approve the same. We believe we can reduce our appropriations even more than we did last year, and still keep our schools up to their high standard.

As you know, the high school tuition is more or less of a problem, as it is hard to estimate how many will attend high school the following year.

We recommend that the town install electric lights in the Great Cranberry Island school in connection with the town hall. We believe it would be policy for the municipal department to handle this, as part of this building is used for town purposes.

In making our appropriations, we are reducing them

as much as we think advisable this year hoping we may be able to reduce still further another year:

Common schools,	\$2,000
Janitors,	418
High school tuition,	500
Text-books and supplies,	200
Fuel,	550
Repairs,	100

This represents a reduction of \$600.
