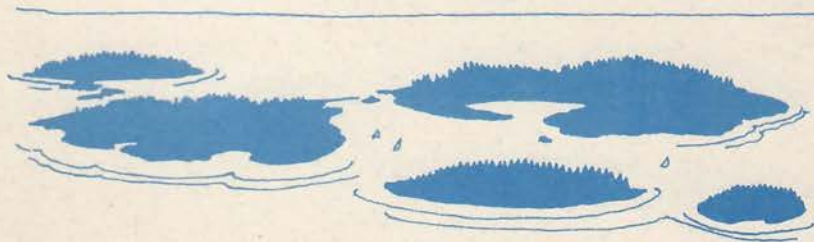

Notice to Taxpayers **IMPORTANT!**

ALL TAXPAYERS SHOULD READ THE
FOLLOWING REQUIREMENTS AND COMPLY WITH THEM.

Maine Revised Statutes Annotated, Title 36, Section 706

Before making an assessment, the assessor shall give reasonable notice in writing to all persons liable to taxation in the municipality to furnish to the assessors true and perfect lists of their estates, not by law exempt from taxation, of which they were possessed on the first day of April of the same year.

The notice to owners may be by mail directed to the last known address of the taxpayer or by any other method that provides reasonable notice to the taxpayer.

If notice is given by mail and the taxpayer does not furnish such list, he is thereby barred of his right to make application to the assessors for any abatement of his taxes, unless he furnishes such list with his application and satisfies them that he was unable to furnish it at the time appointed.

The assessors may require the person furnishing the list to make oath to its truth, which oath any of them may administer, and may require him to answer in writing all proper inquiries as to the nature, situation and value of this property liable to be taxed in the State, and a refusal or neglect to answer such inquiries and subscribe the same bars an appeal but such list and answers shall not be conclusive upon the assessors.

All Subsurface Wastewater Disposal Systems must be inspected prior to covering any part of the system.

Islesford Public Facility Committee

Acadia National Park, which owns and operates the Blue Duck bathroom facility notified the Town several years ago that it wished to cease sharing the use of the facility with the Town as soon as possible. In the past, Islesford Dock Restaurant and the Town have been allowed access after Islesford Museum hours, and each has contributed to maintenance and upkeep. At the 2000 Town Meeting voters decided to form a committee to investigate solutions to the problem. Appointed to the committee were Islesford Dock owners Dan and Cynthia Lief, Courtney Chaplin, Barbara Bryant, Denise McCormick and Jeri Spurling. After consideration of several options, it was decided to propose a joint effort between the Town and Islesford Dock Corporation as set forth in Article 23 of the 2001 Warrant.

Shellfish Ordinance Committee

Concerns about the overharvesting of clams and other shellfish were raised at the 2000 Town Meeting, and it was voted to form a committee to study the matter.

Committee members Rick Alley, Norman Sanborn, Jr., Tim Moran, Richard Stanley, Scott Bracy, Jeremy Alley, Corey Alley, and Harry Alley worked with the Maine Marine Resources staff to modify a standard ordinance to meet the special needs and requirements of the Town of Cranberry Isles.

A public hearing was held on February 20th, 2001 on each Island to discuss the proposed ordinance and make any changes necessary. The final draft will be voted on by ballot at Town Meeting. Copies of the proposed ordinance are posted in post offices in Islesford and Great Cranberry and are available from the Town Clerk

Deer Hunting

Under chairman Rick Alley, the Deer Committee, formed in 1998 to examine the problem of overpopulation of deer on the islands, achieved passage of legislation to enable a controlled hunt in the fall of 2000 and a legal hunting season in the years after.

For the controlled hunt, each hunter was required to have written permission from an island landowner, a valid Maine license, and be free of any criminal record. While actions of some hunters last fall caused complaints, it is expected that a regular season, fewer deer, education and greater participation by wardens will reduce the problems in the future. The count of deer taken is as follows:

Islesford

On Islesford work is being done on the conversion of the town garage to a heated building for both the fire truck and town snow plow. The building has been insulated and two 9'x9' overhead doors have been installed. The old electrical entrance has been replaced with a code compliant system. The new furnace has been ordered and will be installed soon by the heating contractor.

Great Cranberry

After five years as fire chief, Arvard Savage has stepped down, and has been replaced by the election of Norman Sanborn, Jr. We all appreciate Arvard's dedication and hard work during his term and count on his continued support. The department now has 34 dues paying members from among full time and seasonal residents, including, for the first time, a number of women.

Our biggest achievement was a successful fund drive and subsequent purchase of a 4 wheel drive 500 gal. pumper truck, equipped with a generator, which was put to good use during the recent power outage. Fund raising will be continuing to meet the need for an addition to the firehouse to house the new truck, for necessary equipment, and for first aid and fire training sessions. Interior renovation of the firehouse is also being done.

We are grateful to fire departments in N.E. Harbor, Ellsworth, Sorrento, Brewer and Eastport for equipment donations. Items obtained include hose and hose reel, fittings, foam, radios, coats and helmets.

The year 2000 also saw the passing of Harry Alley, Secretary of the Fire Club for 40 years, Carl Strandberg, a long time director, and member Arthur Bunker. Their contributions will be missed.

Independent Auditor's Report on Compliance and on Internal Control over Financial Reporting Based on an Audit of Financial Statements Performed in Accordance with Government Auditing Standards

To the Board of Selectmen
Town of Cranberry Isles
Cranberry Isles, Maine 04625

We have audited the general purpose financial statements of the Town of Cranberry Isles, Maine, as of and for the year ended December 31, 2000, and have issued our report thereon dated February 14, 2001. We conducted our audit in accordance with generally accepted auditing standards and the standards applicable to "Government Auditing Standards" issued by the Comptroller General of the United States.

Compliance

As part of obtaining reasonable assurance about whether the Town of Cranberry Isles Maine's financial statements are free of material misstatement, we performed tests of it's compliance with certain provisions of laws, regulations, contracts, and grants, noncompliance with which could have a direct and material effect on the determination of the financial statement amounts. However, providing an opinion on compliance with those provisions was not an objective of our audit and, accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance that are required to be reported herein under "Government Auditing Standards".

Internal Control over Financial Reporting

In planning and performing our audit, we considered the Town of Cranberry Isles, Maine's internal control over financial reporting in order to determine our auditing procedures for the purpose of expressing our opinion on the financial statements and not to provide assurance on the internal control over financial reporting. Our consideration of the internal control over financial reporting would not necessarily disclose all matters in the internal control over financial reporting that might be material weaknesses. A material weakness is a condition in which the design or operation of one or more of the internal control components does not reduce to a relatively low level the risk that misstatements in amounts that would be material in relation to the financial statements being audited may occur and not be detected within a timely period by employees in the normal course of performing their assigned functions. We noted no matters involving the internal control over financial reporting and its operation that we consider to be material weaknesses.

This report is intended for the information of the management of the Town of Cranberry Isles, Maine. This restriction is not intended to limit the distribution of this report, which is a matter of public record.

Independent Auditor's Report



An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the general purpose financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall general purpose financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

The general purpose financial statements referred to above do not include the general fixed assets group of accounts, which should be included in order to conform with generally accepted accounting principles. The amount that should be recorded in the general fixed assets group of accounts is not known.

In our opinion, except for the effects on the financial statements of the omissions described in the preceding paragraph, the general purpose financial statements referred to above present fairly, in all material respects, the financial position of the Town of Cranberry Isles, Maine, as of December 31, 2000, and the results of its operations and cash flows of its Fiduciary Fund type for the year then ended in conformity with generally accepted accounting principles.

In accordance with "Government Auditing Standards", we have also issued a report dated February 14, 2001, on our consideration of the Town of Cranberry Isles, Maine's internal control over financial reporting and our tests of it compliance with certain laws and regulations, contracts and grants.

Our audit was made for the purpose of forming an opinion on the general purpose financial statements taken as a whole. The schedules listed in the enclosed table of contents are presented for purposes of additional analysis and are not a required part of the general purpose financial statements of the Town of Cranberry Isles, Maine. Such information has been subjected to the auditing procedures applied in the audit of the general purpose financial statements and, in our opinion, is fairly stated in all material respects in relation to the general purpose financial statements taken as a whole.

The above breakdown by grade reflects the number of students who are currently students in the Islesford School, Mt. Desert Island High School and private schools. Since there are no school age children living on Great Cranberry Island, the school is not open this year. The decision was to not permanently close the school at this point in time so that should children come to the island, it would not be complicated to reopen the school. As has been the case for several years now, there has been considerable attention given to the anticipated enrollment of the schools each year and decisions related to these projections. The islands have demonstrated consistent support of the schools, the children and providing the best possible education.

This year the school staff consists of two full-time teachers and several part-time specialists. Angela Hardy and Tim DeSchiffart are team-teaching the children across grades 2-8. They also provide some programming for two preschool age children from the community. Amy Philbrook continues as a professional Resource Teacher for the faculty and Susan Haynes as Special Education consultant. Shira Singer continues as art instructor, Beth Bradshaw as music instructor, Linda Bernstein, guidance services and the YMCA contracts with the school to provide physical education. The students continued to enjoy the visits and talents of naturalist, Scott Grierson. Students who chose to participate had the benefit of the coaching of Eve Harrison for the cross-country team.

The teachers have provided a rich program in the classroom, with high standards. In addition to classroom learning opportunities, a number of enriching experiences were provided to the children of the Cranberry Isles. These include fundraising for and taking a trip to New York City; a French breakfast served for the community; a ropes course field trip; attending a dramatic presentation at the University of Maine on the story of the Freedom Train. A number of educational trips to such places as Acadia National Park to study geology, The Jackson Lab for science, Blueberry and wreath factories to study Maine industry took learning beyond the walls of the classroom and the island.

The island students and teachers brought the island to them by hosting the inter-island event. The students held a solar car competition, a mock election and presented a play, "Toy Camp", all of which wove the community into the process.

The physical plant is solid and serves the students well.

All of the activities that the students participated in over the past year reflect the high caliber of teachers and their willingness to put extra energy into enhancing student learning.

It is true that the island's children are its future. Special acknowledgement is due the school board, the parents, and the entire community for on-going commitment and support for the island school.

Cranberry Isles Ordinances and Regulations

Following are **condensed** selections from Town Ordinances. Copies of the full ordinances are available from the Town Clerk. Please be sure renters or others users of your property are aware of these rules.

Bicycles

Ordinance regulating the use and manner of use of bicycles in the night time, viz: Every bicycle when in use at night shall be equipped with a lamp on the front which shall emit a white light visible from a distance of at least five hundred (500) feet to the front end, and with a reflector on the rear which shall be visible from all distances from fifty (50) feet to three hundred (300) feet to the rear when directly in front of lawful upper beams of head lamps on a motor vehicle. A lamp emitting a red light visible from a distance of five hundred (500) feet to the rear may be used in addition the red reflector. Any person convicted of a violation of the provisions of this ordinance shall be punished by a fine of five dollars and costs.

Enacted March 2, 1992

Parking Ordinance

From the first day of November to the first day of April, no person shall park a vehicle on any street or road in the Town of Cranberry Isles between the hours of 4 p.m. and 6 a.m. for a period of time longer than thirty minutes. Any vehicle found parked in violation of this ordinance and obstructing snow removal or sanding operations may be moved to a storage garage or parking lot at the owner's risk, and the owner shall be charged with storage costs and towing fee. This to facilitate snow removal and sanding.

Enacted March 7, 1966

Ordinance (Dogs)

All dogs must be on a leash except when on owner's property. Whoever violates or fails to comply with the provisions of this ordinance shall be punished by a fine of not less than fifty (50) dollars.

Enacted May 8, 1969

Open Fire Ordinance

Anyone having an open fire, except in an indoor fireplace, shall have a permit in writing from a fire chief or fire warden of the Town of Cranberry Isles.

Camping Ordinances

Anyone camping on the land of others shall have a written permit from the owner of the land.

Docking Ordinance

Pursuant to Title 30, Section 2151, as amended, the Town of Cranberry Isles, Hancock County, Maine, hereby enacts this Docking Ordinance promoting the public convenience and welfare and providing for public safety in the use of harbors, waterways, mooring areas and public docks of the Town.

1. No person shall tie up and leave a boat at any town float or dock for more than two (2) hours except to beach the same for repairs.
2. The head of all town floats and companionways of docks shall be kept clear at all times except to load and unload cargo or passengers.
3. No person in any motor craft shall exceed five (5) miles per hour through the mooring areas of the town's harbors.
4. All moorings shall be rigged and placed so they do not create an excess hazard to marine traffic.
5. Anything shall not be left upon a float more than one hour unattended by the person therefor.
6. Docks are public ways. Passage of the traveling public, including motor vehicles at Great and Little Cranberry Islands, shall not be unreasonably obstructed. Traps, materials, packages and other objects may be left thereon, in such a manner that passage along the dock is not obstructed, for no longer than 72 hours. A similar ordinance enacted in 1969 is repealed.
7. Building on the docks are public buildings intended for the temporary shelter of persons and perishable objects and materials. Anything placed within such buildings shall be removed within 72 hours.
8. Failure to comply with these regulations shall result in a warning or a fine of not more than \$50.00 nor less than \$20.00.
9. Harbor masters and Constables of the Town of Cranberry Isles, Maine shall have the authority to enforce this ordinance.

Notice to Owners of Motor Vehicle or Boat

If you own a motor vehicle or boat, and are not entitled to an exemption under Maine law, it is your responsibility to pay an annual excise tax to the Town of Cranberry Isles (MRSA Title 36 §1482 C and 1501). The town retains all excise tax money. The voters of the Town appropriate all excise tax money to the General Fund. Motor vehicles must be registered annually (MRSA Title 36 §102 and 242). Evidence of insurance must be shown before a motor vehicle is registered or re-registered. 75% of registration fees are returned to the Town and expended on town roads. If you have any questions as to the status of your motor vehicle or boat excise tax, please call the Tax Collector at 244-5943. The Tax Collector will also answer any questions as to the status of your motor vehicle or boat.

Notice to Applicants for Permits

While the Town of Cranberry Isles is the proper official to file all applications within the municipality of Cranberry Isles, neither the Town Clerk nor any other town official has the authority to answer questions or provide information which an applicant may rely upon. Only the board or officer which will grant or deny the application can do so. Applicants are hereby notified that any reliance on information other than that from the proper authority is done so at their own risk and shall not be binding on the municipality.

Building Regulations

All permit applications and notifications should be filed with and directed to the Code Enforcement Officer. Application forms may be obtained from Mr. Leavitt or from the Town Clerk.

Notification of Intent to Build

All new buildings or additions require a Notification of Intent to Build. There is no fee for filing this notification.

Zoning Permits

All new buildings or additions within 250 feet of the shore or within 250 feet of freshwater wetlands or over or in water require a zoning permit. In these areas site clearing, timber cutting, road building, and similar operations are also covered by this permit requirement.

Site Plan Review

If you are building, altering, or enlarging a business, or converting a private use to business use in any location, you need a Site Plan Review by the Planning Commission. Attached multi-family housing also requires Site Plan Review.

Subdivisions

Division of land into three or more lots within a five-year period may require a Subdivision Permit.

Other Permits

Permits are required by the State of Maine for sewage disposal and plumbing systems. Building operations with the Shoreland Zone or in the water may require permits from the Department of Environmental Protection, Corps of Engineers, or from the Selectmen, and business uses may require additional permits.

The Code Enforcement Officer can guide you in these requirements.

To see what sum the voters of the Town of Cranberry Isles will authorize the School Committee to expend for the fiscal year beginning July 1, 2001, and ending on June 30, 2002 from the foundation allocation, debt service allocation, unexpended balances, tuition receipts, local appropriations, state subsidy, and other receipts for the support of schools.

22. To see if the voters of the Town of Cranberry Isles will form a committee to investigate employment of and appropriate compensation for a town administrator who's duties might include:
 - Right of way and road maintenance
 - Maintenance of town floats and wharves
 - Care of town properties
 - Maintenance of town buildings
 - Monitoring and enforcement at Joy Rd parking lot
 - Overseeing town contracts
 - Filling appointed offices as Selectmen may require
 - Any other functions not now being carried out
23. To see if the voters of the Town of Cranberry Isles will vote to appropriate the sum of \$20,000 to construct a subsurface sewage disposal field on town owned land at the Islesford ball field, to be connected to toilet facilities available for year around public use, constructed by and at the expense of the Islesford Dock Corporation at the head of the Islesford Dock wharf.
24. To see if the voters of the Town of Cranberry Isles will vote to join with other communities in support of the Island Explorer transportation bus system, and if so, the sum to be appropriated.
Recommended: \$750
25. To see if the voters of the Town of Cranberry Isles will vote to accept a bequest of \$1,000 made under the will of Wesley Bracy, Sr to the Bunker Cemetery, and will administer the fund for the purpose of maintaining the cemetery.

26. To see what sum the voters of the Town of Cranberry Isles will vote to raise and appropriate for each function of Town operations as shown in the Town Operations Budget. Each function shall be voted on.
